

3M Green Flag Sweepstakes and Instant-win Game Official Rules.

1. NO PURCHASE NECESSARY. A purchase will not increase your chances of winning. Promotion is subject to the following rules and regulations.

2. After you submit your information, you will receive one automatic entry for the First Prize Trip for 2. Only one entry per day is permitted. Before entry can be accepted, understanding and acceptance of the Official Rules must be acknowledged by each entrant by clicking on the “I have read and agree to the game’s official rules” check box.

3ii. HOW TO PLAY THE INSTANT-WIN GAME:

i. One (1) First Prize: a VIP trip for two (2) to a NASCAR® NEXTEL CUP SERIES Race held in Michigan in August, 2008. Approximate Retail Value (“ARV”): \$6,000.00.
